

**COMPREHENSIVE FORM**  
**2010 China Educational Tour (“The Tour”)**

**1. PROGRAM RULES**

- a. **GOVERNMENT LAW**—Participants must abide by all applicable laws.
- b. **OTHER REGULATIONS**—Participants must abide by policies set forth by the:
  - i. Global Perspectives for Youth, LLC (“GPY”) and
  - ii. Host Family
- c. **ATTENDANCE**—Participants must attend all scheduled programs and abide by all applicable procedures.
- d. **EXCUSED ABSENCE**—Tour staff may authorize absences for sickness, injury, or other acceptable reasons.
- e. **SAFETY**—Participants must not commit any act that jeopardizes the safety and well being of others. Participants may not depart from group without permission.
- f. **ILLEGAL SUBSTANCES / WEAPONS**—Participants may not use or possess illegal substances, or weapons under any circumstances.
- g. **ALCOHOL**—Participants under 21 are not permitted to consume alcohol under any circumstances.
- h. **ADULT THEMED ESTABLISHMENTS**— Participants are not permitted to go into any adult themed establishments.
- i. **CONSEQUENCES**
  - i. Participants in violation of any of the above program rules will be issued warnings and/or other sanctions at the discretion of tour staff.
  - ii. For certain violations, GPY reserves the right to suspend or dismiss participants from the program without refund.

**2. LIABILITY RELEASE**

- a. **PROGRAM RULES**—I have read and agree to abide by each of the above Program Rules designed to help ensure safety of all tour participants.
- b. **VOLUNTARY PARTICIPATION**—I acknowledge that my participation in the tour and related activities is completely voluntary.
- c. **INHERENT RISKS**—I recognize the inherent hazards and dangers associated with tour activities, events, and other programming. These include, but are not limited to scheduled sports activities, swimming, inclement weather, and transportation.
- d. **SAFETY MEASURES**—I understand that although GPY will take all reasonable safety measures to minimize the risk of harm to participants, GPY cannot ensure that activities, equipment, and/or premises will be free from any and all possible hazards.
- e. **VALUABLE ITEMS**
  - i. I acknowledge that I bring cash, jewelry, camera, laptop computer, electronics or other valuable items to the tour at my own risk. I hereby assume full responsibility for such items and release GPY and the host families, or any other party involved with the tour from any loss, damage, or theft of personal belongings that may occur.
  - ii. I understand that hand held video games, MP3 players, DVD players, laptop computers, and comic books are permitted. My use of such items is subject to tour staff discretion. I acknowledge that these items may be confiscated if used at inappropriate times.
- f. **LIABILITY RELEASE**
  - i. I hereby release GPY, as well as parties involved with the tour, including, but not limited to, schools and host families, from any and all claims, demands, and causes of action on account of any injury, illness, loss, death, or damage, to whatever extent such occurrences may arise, during tour participation.
  - ii. I understand that GPY will purchase medical insurance for me for the duration of the tour. I may contact GPY for details regarding coverage.

**3. PERSONAL LIABILITY**

- a. I hereby assume any and all liability for damages, including but not limited to clean up costs, caused by my willful or negligent conduct to property owned by host family, schools, GPY, or any other party involved with the tour.

**4. MEDICAL INFORMATION**

**6. PAYMENT / CANCELLATION / REFUND**

- a. **PAYMENT**—non-refundable \$150 deposit is due upon registration. GPY will help set up a monthly installment plan. The tour balance is due 110 days before departure (**March 3, 2010**), unless otherwise allowed.
- b. **CANCELLATION**—requests must be submitted in writing, prior to departure. GPY reserves the right to cancel, modify, or delay the tour due to unforeseen circumstances beyond GPY’s reasonable control.
- c. **REFUND**—Except for the non-refundable \$150 deposit, refunds will issue as follows:
  - i. 100% if 170 days before departure (**January 2, 2010**);
  - ii. 75% if 140 days before departure (**February 1, 2010**);
  - iii. 50% if 110 days before departure (**March 3, 2010**);
  - iv. 25% if 45 days to 109 days before departure (**March 4 to May 7, 2010**);
  - v. No Refund
    - 1. No refund will issue at any of the following times:
      - a. 44 days (**May 8, 2010**) or less before departure
      - b. after departure
      - c. cancellation not submitted in writing before departure.
    - 2. Note: GPY recommends Tour Cancellation & Interruption Insurance. Ask tour staff for details.

- 7. **SIGNATURE**—I hereby acknowledge that I have read all of the above and fully understand the (1) Program Rules, (2) Liability Release, (3) Personal Liability, (4) Medical Information, and (5) Photograph, and (6) Payment/Cancellation/Refund sections of this Comprehensive Form.
